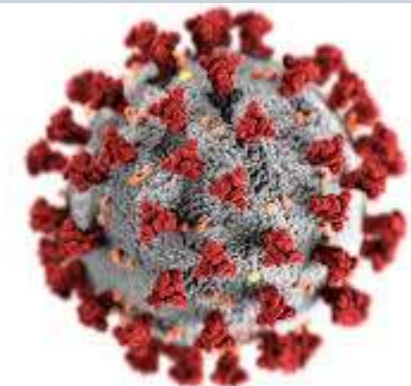

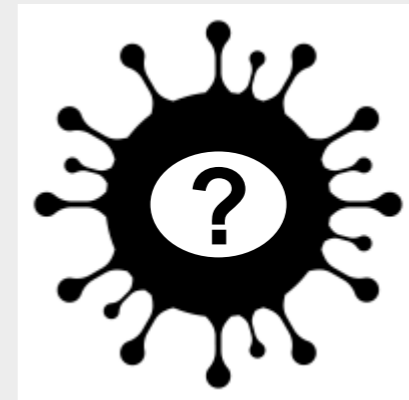

- 1 329 000 people
- 12 000 horses
 - Slowly but constantly increasing
- Mostly hobby horses
- Main competitive discipline is showjumping; dressage and eventing in lesser extent
- Knowledge is increasing, still a lot room for improvement

About EEVA

- Established in March 2018
- Currently we have 7 members: 4 founding members and 3 joined members
- So far EEVA has been quite inactive but we are now taking steps to change that
- Additionally, we work to improve membership benefits and plan to welcome new members after (hopefully) joining FEEVA
- We estimate the number of members to be around 20-25 in the future

Purpose of our association

- Unite equine veterinarians in Estonia
- Improve international relationships with other organisations connecting equine veterinarians
- Increase the value of equine professionals in Estonia
- Enhance and equalize the standard of veterinary care for horses in Estonia
 - Currently we have disparity between the level of equine medicine offered in the university clinic and in the field

Aims of our association

- Educate equine veterinarians/mixed practitioners who have interest in equine medicine
 - at least one larger specialized course for members per year
- Support for recent graduates working in the field
- Educational days and information regarding equine welfare for horse owners

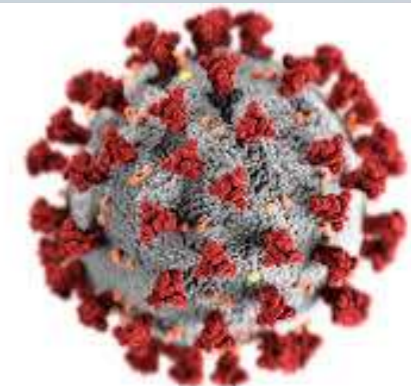
